#### **2 PRESENTATIONS**

# **Brett Mattson and Archie Hooper (Airgentic - Al Citizen Service)**

Sean Holden introduced Brett Mattson and Archie Hooper, of Airgentic. Brett provided a brief introduction to their AI product which has been implemented by both the District Council of Mt Remarkable and The Flinders Ranges councils as an overlay to frequently asked questions, providing

efficiencies in directing people to required information and follow-up. The product:

- I. Reduces the load on human contact centres
- 2. Enhances 24x7 customer self-service support
- 3. Increases contact centre team productivity
- 4. Gathers actionable customer insights.

The program also works well with CMS systems and provides website integration, for consistent accuracy and tone of messaging.

The Airgentic team can configure the service; review and test, with up to 15 hours of training, and live analytics. Back-up of data is also ensured, and councils own the data.

# Andrew Lamb Presentation (LGA)

Andrew Lamb presented at the meeting in relation to Local Government Elections and correspondence from the Minister.

It was noted that the date would not change for council elections, in the same year as a state election. There is a Bill to parliament this year so the electoral commission and councils can start planning in relation to future organisation of the timing of elections.

Elected member behaviour has been moved into the Upper House Parliament as an issue for review. LGA has engaged Flinders University to research this issue and the LGA is working on a support package for councils.

It was noted that the drought continues to be an issue, and the federal government has just also announced more funding in this regard. A submission has also been made to the state government in relation to a rates deferral program.

The LGA has also been looking at initiatives in relation to the long-term financial sustainability of councils. Other items:

- Need for an increase in Special Local Roads Program funding
- CEO remuneration tribunal pending
- LGA State Election platform
- Electricity generators bill (Hon Frank Pangallo).

It was noted that the Northern & Yorke region was not included in drought discussions at the LGA/State Government level and there is a need in future to have representation from the region at any future discussions of this type going forward.
